DEAR TRAVELERS, WHETHER YOU ARE ARRIVING ON NATIONAL TERRITORY OR LEAVING IT, BY LAND, SEA, OR AIR, TO FACILITATE YOUR PASSAGE, THE ALGERIAN CUSTOMS ADMINISTRATION PROVIDES  
A **DIGITAL SERVICE**  
ACCESSIBLE REMOTELY, ALLOWING YOU TO SUBSCRIBE TO THE **CUSTOMS TRANSIT PERMIT (CTP)**  
FOR YOUR VEHICLE WHEN CROSSING LAND OR MARITIME BORDERS.



**1** WHAT IS THE CUSTOMS TRANSIT PERMIT (CTP) ?

THE CTP IS A MANDATORY DOCUMENT FOR :

- TEMPORARY ENTRY INTO ALGERIA OF VEHICLES REGISTERED ABROAD.
- TEMPORARY EXIT FROM ALGERIA OF VEHICLES REGISTERED IN ALGERIA.

THIS DOCUMENT ALLOWS VEHICLES TO CIRCULATE UNDER A TEMPORARY CUSTOMS REGIME, IN ACCORDANCE WITH THE AUTHORIZED TIME LIMITS.

**2** WHO CAN BENEFIT FROM THE CTP ?

THE CTP IS INTENDED FOR :

- NON-RESIDENT NATIONALS: ALGERIANS LIVING ABROAD ENTERING WITH A FOREIGN-REGISTERED VEHICLE.
- FOREIGN NATIONALS VISITING ALGERIA TEMPORARILY.
- RESIDENTS (NATIONALS OR FOREIGNERS): ALGERIANS RESIDING IN ALGERIA WISHING TO TEMPORARILY TAKE THEIR VEHICLE ABROAD.

**3** CONDITIONS FOR ISSUANCE OF THE CTP :

REQUIRED DOCUMENTS :

FOR ALGERIANS RESIDING ABROAD :

- VALID PASSPORT
- RESIDENCE OR RESIDENCY CARD
- VEHICLE REGISTRATION CARD

FOR FOREIGN NATIONALS :

- VALID PASSPORT
- VEHICLE REGISTRATION CARD

FOR ALGERIANS RESIDING IN ALGERIA :

- VALID PASSPORT
- VEHICLE REGISTRATION CARD
- CAR INSURANCE
- PROOF OF PAYMENT OF THE INDIVIDUAL TRANSPORT TITLE TAX (FOR LAND BORDERS)

**4** VALIDITY PERIOD OF THE CTP :

THE CTP IS ISSUED FOR A LIMITED PERIOD :

FOR ALGERIANS RESIDING ABROAD :

- VALID FOR SIX (06) MONTHS, NON-RENEWABLE, WITHIN A TWELVE (12) MONTH PERIOD .

FOR FOREIGN NATIONALS :

- VALID FOR THREE (03) MONTHS, RENEWABLE UP TO SIX (06) MONTHS.

FOR ALGERIANS RESIDING IN ALGERIA :

- VALID FOR SIX (06) MONTHS (FOR VEHICLES WITH NATIONAL LICENSE PLATES)

- THE DEADLINES MUST BE STRICTLY RESPECTED UNDER PENALTY OF SANCTIONS.
- IT IS FORBIDDEN TO SELL, LEND, OR TRANSFER THE VEHICLE UNDER CTP WITHOUT CUSTOMS AUTHORIZATION.
- THE CTP MUST BE RETURNED TO CUSTOMS AT THE TIME OF EXIT OR UPON THE VEHICLE'S RETURN.



ANY UNREGULARIZED OVERSTAY IS SUBJECT TO FINES.

**5** ALCES: ONLINE CTP REGISTRATION !

THE ALCES SYSTEM (ALGERIAN CUSTOMS ELECTRONIC SYSTEMS) FACILITATES THE DECLARATION AND REGISTRATION OF THE CTP BEFORE ARRIVING IN ALGERIA OR BEFORE LEAVING THE NATIONAL TERRITORY.

ADVANTAGES OF THE ALCES SYSTEM:

- SAVES TIME AT BORDER CHECKPOINTS
- SIMPLIFIED AND SECURE ONLINE DECLARATION
- REAL-TIME TRACKING OF CTP STATUS

HOW TO REGISTER YOUR CTP VIA ALCES ?

- 1 SCAN THE QR CODE TO ACCESS THE «ALCES» PLATFORM DIRECTLY, OR GO TO THE FOLLOWING ADDRESS : **alces.douane.gov.dz**
- 2 CREATE AN ACCOUNT AND FILL OUT THE ONLINE FORM
- 3 UPLOAD THE REQUIRED DOCUMENTS (REGISTRATION CARD, INSURANCE, ID, ETC.)
- 4 VALIDATE AND RECEIVE YOUR CTP COPY ONLINE.
